Privacy Policy

1. Who is responsible for managing my information?

The Mill Sussex and all websites and brochures operated and/or produced in relation to it are owned and maintained by The Mill Sussex ("we" or "us"). This is our Privacy Notice and it explains how we collect, use, share and protect your personal data.

We may do this by phone, email, text, WhatsApp or postal mail using the information you have supplied on your booking form.

5. Where is your information stored?

Our website is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to sell our products and services to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.

6. Third parties

We will not share your information with any third parties

Any information collected via our website (For instance via our website enquiry form) is securely stored on our website platform provided by Wix (www.wix.com). Wix does not use any of this data itself and will not use it to contact you, or to share your information with third parties. - to stop processing any of your personal data that we process on the basis of our legitimate interests; and
- to stop sending you marketing material. However please note that we may continue to send you service related (i.e. non- marketing) communications, such as email updates

Where we have reached a decision that affects you by processing your personal data automatically then you have the right to speak to someone to discuss that decision. We do not use your personal data for the purpose of profiling. Where we process your personal data on the basis that you have given us your consent to do so then you may contact us at any time to withdraw your consent
